

NSW Litter Prevention Strategy update and progress to state targets

John Lavarack, NSW Environment Protection Authority

The NSW Litter Prevention Strategy 2022-2030 is now in its four year, and showing initial signs, through the Key Littered Items Study, that the single-use plastic phases out in late 2022 are already having an impact on litter levels. An update will be provided with a snapshot of latest litter data and progress to targets, as well as delve into the NSW EPA's litter prevention grants, the new streets to sea grant program and provide a preview of new anti-littering state campaign.

Beyond the Ban: Voluntary behaviour change for plastic reduction

1100 Curby: Rebuilding trust in Australian soft plastics recycling

Hannah Partland, Curby

Curby's smart recycling platform is the solution for enabling Australians to recycle their problematic materials, such as soft plastics. Learn how Curby is changing the way soft plastics are collected and recovered with the support from four NSW councils and over 40,000 active users.

From Single-Use to Second Life: A solution to plastic pollution

ADDRESSING TOBACCO AND VAPE LITTER CHALLENGES

1330 Collaborating for state-wide action on tobacco waste Shannon Mead, No More Butts

Cigarette butts remain one of the most littered items in NSW and in Australia. With the EPA having a milestone of a 50% observed reduction in cigarette butt littering by 2030, No More Butts has been working with councils and partners to identify methods to hit this target.

Unfiltered: The regulatory issues affecting the reduction of cigarette butt litter

This presentation explores the regulatory challenges impacting cigarette butt litter reduction in Australia, including weak enforcement, lack of product stewardship, emerging vape waste, and the need for stronger national coordination through consistent legislation, targeted funding, and support for local government education and infrastructure programs

This presentation will help councils understand their powers under the *Protection of the Environment Operations Act 1997* and Local Government *Act 1993* to enforce illegal dumping laws, and to recover expenses associated with cleaning up illegally dumped household waste.

Explore how Operation Clean Sweep helps prevent plastic feedstock pollution through education and enforcement. The program supports compliance with NSW EPA requirements under the Protection of the Environment Operations Act, helping councils and communities reduce microplastic pollution at the source.

The Pollution Divide: Comparing Urban Litter and Stormwater Pollution

Daniel Rider, Ocean Protect & Kenneth Fitzgerald, Blacktown City Council

This presentation shares insights from a short-term exploratory study conducted by Blacktown City Council and Ocean Protect. The study compared litter and stormwater pollution on a commercial site in Western Sydney. Blacktown City Council surveyed the site for litter, while Ocean Protect monitored stormwater pit inserts to assess stormwater pollution.

From Pollution to Participation: The Satyaam Ghat Story Sam Nasser & Laura Parent, Liverpool City Council

This session showcases the Satyaam Ghat activation project, highlighting how culturally sensitive engagement, education, and collaborative action led to a 70% litter reduction and renewed community ownership. It explores lessons learned in empowering diverse communities to protect urban waterways through inclusive, place-based environmental initiatives.

Caring for Woollahra's harbour beaches with corporate volunteering

Michelle Rose, Woollahra Council

Litter in Sydney Harbour is a significant problem. To reduce litter on our beaches and raise awareness of plastic pollution Woollahra Council established our HarbourCare program. The program has evolved from attracting a handful of individual volunteers in 2017 to enabling 65 corporate clean-ups in 2024 with over 1,200 participants.

Tackling recreational fishing litter in NSW Emma Kark, OzFish Unlimited

OzFish is tackling recreational fishing litter with community-driven programs that influence ideal behaviours for litter prevention. Collaborating with community, councils and key industry stakeholders, the project addresses barriers from manufacturing, usage, and then disposal, working towards a circular economy.

Gladesville Litter Reduction Project

Kylie McMahon, City of Ryde

The Gladesville Litter Reduction Project was a catchment based project targeting the removal of gross pollutants impacting the waterway health of the Parramatta River. The grant project combined infrastructure installation, targeted litter hotspots and mixed engagement community education connecting urban impacts to water quality issues.

Delivering a successful public place recycling service that is adopted by community, has low contamination, and compliments current public waste services. A 12-month trial ended in finding a successful way to deliver public place recycling in a Sydney council area.

Following his pivotal role in the Australian leading Blacktown City Council WSUD Compliance Program, he joined Ocean Protect to lead the development of the WSUD Maintenance Compliance Framework. To assist with the development of this Framework, he also started the National WSUD Compliance Network, a platform that has brought together over 100 professionals, fostering collaboration and knowledge exchange on WSUD compliance.
