The 2020 year was unprecedented, not only for KAB NSW but the entire charity sector, the community, the industry sectors in which we operate and the broader economy. I would also like to congratulate Murrurundi (Upper Hunter Shire Council) who as the Overall Sustainable Communities Tidy Towns Awards winner for 2019, represented NSW in the Australian Sustainable Communities Tidy Towns Awards. A delegation of KAB NSW Directors and staff joined the Murrurundi community in October 2020 to watch the online awards ceremony where Murrurundi was awarded winner of the Environmental Sustainability - Water Category.

Our Annual Litter Congress is the only conference in Australia devoted solely to addressing the litter problem, and due to COVID this year, like so many other events, had to be postponed. The Litter Congress has solidified its place as a home for information and inspiration from local government and the community that will ultimately lead to action in the environmental sector and KAB NSW is well into the latter stages of finalising the event to be held now on 20th and 21st April 2021.

During the second half of 2020, the KAB NSW team commenced a program to build our communications, engagement and partnerships in 2021 utilising the KAB NSW newsletters, social media channels and faceto-face visits to stakeholders in both metro and regional areas.

Alvin is the founder and former managing director of TES-AMM Australia and New Zealand which is part of the TES Group




of companies, a leading global IT sustainability services company.

Sustainable Cities & Sustainable Communities Awards





The Sustainable Communities – Tidy Towns and Sustainable Cities Awards Programs reward and celebrate the achievements of NSW groups, businesses, schools, individuals, and Councils in keeping our state sustainable.

These annual awards programs recognise projects that reduce litter, minimise waste, encourage recycling, promote heritage and culture, habitat, celebrate community spirit and many other environmental areas.

2020 marks the third year since the return of the Sustainable Communities Tidy Towns and Sustainable Cities branding and it is encouraging to see that participation in and enthusiasm for the program are increasing despite the significant challenges of fires, floods and flu (COVID) experienced across NSW during 2020.

In the Sustainable Cities Program entries were received from 20 Councils, 9 Community Groups, 7 Schools, 4 Businesses and 3 Individuals, with many entrants submitting multiple projects - some as many as 15 entries!

In the Sustainable Communities Tidy Towns Program, entries came from 10 Councils, 20 Community Groups, 8 Schools, 3 Businesses and 1 Individual. Once again, many entrants submitted multiple projects across multiple categories.

The range of applications was extremely varied and summaries of the winning and highly commended projects available in each program's winners book available on the KAB NSW website (the Sustainable Communities Tidy Towns Winners Book will be released after the awards announcement in March 2021).

The Sustainable Cities Awards Ceremony hosted by 2019 winner, Cumberland City Council, was originally due to be held in October but due to COVID was postponed to 12 November 2020. The Sustainable Communities Tidy Towns Awards event will be held in Murrurundi (Upper Hunter) from 12 – 14 March 2021.

An enormous thank you must go to the Awards Judges and Assessors who did an amazing job reviewing and scoring a record-breaking number of entries. There is an amazing wealth of knowledge, expertise and experience across the panel and we are extremely grateful for the time and support our judges have so generously given.

EnviroMentors®

EnviroMentors® are proud to remain NSW's leading sustainability education program. We understand that sustainability and waste issues differ across the state and specifically tailor our workshops to address the unique issues faced by each Local Government Area. Getting students excited about and engaged in sustainability and waste reduction workshops is achieved through a combination of age, learning style and skill tailored workshops presented by educators with a passion for conservation and teaching.

2020 was a challenging year for all and saw the EnviroMentors® program effectively shut down over Term Two, as the country went into lockdown. Happily, as we saw cases drop the program gained momentum again over Term 3, finding us back to a new normal in Term 4. Despite the challenges, we still reached approximately 17,338 students from 104 schools across 18 LGA's in NSW.

From preschool, primary school, teachers, educators and support staff, the EnviroMentors® program explored and informed on sustainability issues relevant to each local area in our interactive workshops.
